- The enrolled child herein will attend Good Shepherd Lutheran School and participate fully in its educational programs
- Good Shepherd Lutheran School will make available its full range of classroom, educational, religious, and/or child care programs to the enrolled child
- Payment will be made by the first day of school for all tuition and fees as specified by the school unless a Tuition Payment Plan has been approved
- If, for any reason, the ability to meet this financial obligation is in jeopardy, either temporarily or indefinitely, immediate discussion of the matter will take place with a member of the School Board.
- Failure to make financial payments will result in the School Board of Good Shepherd Lutheran Church and School to take such action as it deems necessary including, but not limited to, suspending the enrolled child from attendance at school or child care programs pending payment of the past due account. Where no other alternative appears feasible, the enrolled child's right to attend school/child care programs may be terminated.
